INFECTED BLOOD INQUIRY

WRITTEN STATEMENT OF ELIZABETH REDMOND

I, Elizabeth Redmond, in response to the Rule 9 request from Deirdre Domingo, Deputy Solicitor to the Infected Blood Inquiry dated 10 January 2020, addressed to the Department of Health, will say as follows:

1. Please set out your name, address and your role within DHNI

- 1.1 I am the Director of Population Health in the Department of Health (Northern Ireland) and am based in Castle Buildings, Stormont Estate, Belfast. As Director of Population Health I am responsible for development and oversight of policy specific to protecting and improving population health. I report through the Deputy Chief Medical Officer (Public Health), Dr Naresh Chada, to the Chief Medical Officer, Dr Michael McBride.
- 1.2 The Northern Ireland Executive sets out its priorities by way of the Programme for Government, focused on achieving outcomes of societal wellbeing. The Programme for Government framework is used as the basis for the Outcomes Delivery Plan, which sets out the actions that departments are taking to give effect to the Executive's stated objectives of improving wellbeing, by tackling disadvantage and driving

economic growth. I am the Senior Responsible Officer for four indicators within the Outcomes Delivery Plan: increasing healthy life expectancy; reducing the inequality gap in healthy life expectancy; reducing preventable mortality; and reducing the proportion of children born at low birth weight. Population Health Directorate (PHD) comprises four branches: Health Protection, which includes responsibility for blood safety and the response to the UK Infected Blood Inquiry; Emergency Planning; Health Improvement Policy; and Health Development Policy.

The Inquiry understands that: (a) in October 2018 NHS England announced funding (of up to £50 million) for a new screening service to be put in place to provide long term support and treatment for people with physical and mental health issues following the Grenfell Tower fire; and (b) a free and confidential NHS service (the Grenfell

Health and Wellbeing Service) is available to children and adults affected by the Grenfell Tower fire.

Please confirm whether there is any equivalent or similar service in Northern Ireland for people infected or affected in consequence of infected blood or blood products. If so, please provide details of the service(s). If not, please explain why.

- 5.1 A Clinical Psychology Service is provided by the Belfast HSC Trust in the Clinical Health Psychology Department on the Royal Victoria Hospital (RVH) site. It provides a dedicated service for individuals or family members affected directly or indirectly by the Infected Blood Inquiry (IBI) and by associated health conditions. The service commenced in January 2019 when non-recurrent funding was provided by the Department of Health (NI) for three years from 2018/19 to 2020/21 inclusive
- 5.2 There has not been a systematic whole-programme approach to psychological support for those infected and / or affected in Northern Ireland, analogous to the UK government's response to the Grenfell Tower fire. This may be explained to some extent by the fact that the life-changing and tragic impacts of contaminated blood and blood products became evident gradually over a period of decades, as the number of individual cases accumulated, rather than occurring as a single calamitous event with multiple casualties such as the Grenfell Tower fire. Even as the scale of the impacts of contaminated blood and blood products has come to light, the case for a dedicated, systematic psychological support service in Northern Ireland has only become apparent through the proceedings of the Infected Blood Inquiry. With the restoration of devolved government in Northern Ireland, the Department is reviewing the Infected Blood Payment Scheme (NI) and the need for psychological support will be considered as part of that review.
