## **Infected Blood** Inquiry

# Newsletter

The Inquiry's public hearings start on 30 April this year, and over 11 weeks Sir Brian Langstaff will hear directly from people who were infected by blood or blood products, and from the people close to them who were affected by this. These hearings will take place across the UK on the dates set out below.

It will be possible to register to attend hearings on specific days once the Inquiry publishes the details of who is giving evidence. We are aiming to do this in stages, with details for the first weeks of hearings expected in early April.

We have also today published a document (enclosed with this newsletter) that explains how the Chair of the Inquiry will decide who will be asked to give oral evidence during the hearings.

Given that we are expecting approximately 2500 written statements, it is not possible for everyone to give oral evidence. However, every written statement will be read by the Chair and inform his findings. We expect that around 120 people will be able to give evidence during this phase of hearings. There will be further opportunities for people infected and affected to give oral evidence later in the Inquiry.

#### **Inquiry Intermediaries**

Some people have told the Inquiry that they would not feel comfortable with giving a witness statement in the traditional way. To ensure that these people can still share their experience with the Inquiry, we have recruited three people (Jackie Wilson, Pam Allen and Kay Durrant) to act as "intermediaries". Pam, Kay and Jackie are experienced in social care and policing: they will visit people who would like to share their experience through a conversation, and provide summary reports to the Chair of the Inquiry covering the themes gathered from conversations with a number of people.



As with the witness statements, every report will be read by the Chair and his team, and published with other Inquiry evidence. The intermediaries may be asked to speak about their reports during the Inquiry's hearings.
