You will wish to be aware that the EC are considering deferral of UK donnors and those who have lived in the UK during the time BSE was epidemic because of the theoretical risk of transmission of vCJD. This follows the FDA and Canadian decisions last year. Despite all Member State experts 9apart from Austria) indicating that this should not be done in response to a 20 question survey, the Commission are pushing ahead using CPMP and the BWP. The UK is in a difficult position because opposition on our part is likely to cause political flack and risk the re-accusation that we caused vCJD by adopting the same negative approach to regulation in the past. And in any case there is no further action we will need to have to take.

In effect we have done all we can nationally. And as recently as last September/October CSM and SEAC indicated that no further action was required to reduce the nrisk of vCJD transmission through the blood and blood products in the UK. However MSs may feel exposed by the regulatory action taken by other countries including US, Canada, New Zealand Japan and Israel....though the push is not coming from individual MSs but the EC.

CPMP and DG SANCO (formerly DGV) -the DG which now has responsibility for blood safety are combining with the CPMP Biotech Working Party (BWP) to carry out a survey of travel within the EC between Member States and the UK with a view to developing deferral criteria. These would need to balance the impact of any such restrictions on the availability of blood to national populations against the theoretical risk of transmitting vCJD in this way......the impact od US type regulation for exampkle would rule out about 60% of the Irish Republic's donors, and up to 20% of those in France.....and of course 100% of those in the UK!!!!!!!!!!!!

There is great concern about the wisdom of this action, the logic behind it, the science such as it is and the media imact on public opinion and voluntary blood donation.

I would be grateful if in the first instance UKREP could be aprised of this proposed EC action and there may be a need to inform our embassies of the potential political/media attention.

Dear Colleagues,

At their January meeting, the CPMP agreed that the survey on the travel patterns of European donors to the UK be carried out using a harmonised questionnaire. This issue is now on the agenda for the February BWP meeting when the objectives will be:

- 1. To reach agreement on the key common elements (i.e. time periods for stay in the UK) for the questionnaire to ensure that results from the individual Member States can be compared.
- 2. To estimate when results of the surveys will be available in order to commence organisation of follow-up meeting.
- 3. To consider scope of the follow-up meeting. An update meeting with a similar format to the TSE meeting held in January 1999 is suggested. This meeting would concentrate on human TSEs.

The papers have been circulated in the pre-meeting post and the French questionnaire was also sent on 13 January.

We have heard from DG Sanco (Health and Consumer Protection) that this issue

has been discussed with Commissioner Byrne. They have been instructed that

DG Sanco, in close cooperation with DG Enterprise, should take the lead and

distribute the final version of this survey questionnaire during the next meeting with blood experts on 18 February. (The survey questionnaire would

clearly reflect the role of the EMEA/CPMP).

Since the February BWP and CPMP are prior to the DG Sanco meeting, this should allow us to provide DG Sanco with our recommendations for the questionnaire in advance of their meeting.
