Following my return to the office today I have not caught up with the flurry of emails concerning the appointments process to set up the Skipton Fund Appeals Panel.
I fully concur with the plea made by colleague Sylvia Shearer that the advert and background information that reference to the Government should incorporate the phrase "on behalf of the four UK administrations". I also agree with Sylvia's other suggestions regarding the inclusion of independent before Appeal Panel (line 5 of the advert) and with respect to location is it necessary to be prescriptive at this stage?
As pointed out by Sylvia the reference to the four UK administrations will hopefully help us to deflect strong representations from lobby groups and MSPs that there should be a Scottish version of the panel. With this in mind I must also stress the importance of advertising the positions in the Scottish press. I note with interest that you mention the Guardian as a UK publication for the lay member position, but I am certain that its readership in Scotland is not particularly high. We would therefore wish to advertise the Appeals Panel positions in the Scotsman, Herald, Aberdeen Press and Journal and Dundee Courier. I accept that we will need to pay the advertising costs, but this is a small price to pay given the need to protect our Ministers and senior officials from criticism from Scottish interests. For the QC post in Scotland I would have recommended the Scots Law Times and I am therefore content to see that Jan Nicholls supports this approach.
I have nothing further to add regarding the content of the advert and background note and look forward to seeing final drafts in good time so as to allow for advertising Scottish wide in tandem with that elsewhere across the UK.
Meantime I am happy to discuss further.

QC or Senior lawyer post For the Senior lawyer post NHSAC will advertise in the Law Society Gazette and the Scottish Law Society.

For the QC post the publication Counsel was proposed, but this only covers Wales and England. Its not clear if it includes N Ireland. Chris agreed to look for a suitable publication in Scotland.

For medical appointments - NHSAC will advertise in BMJ. Copies of the advertisement will also be sent to, Royal Colleges of General Practitioners, and Royal College of Pathologists (both UK organisation, who may pass the advert to members who are interested). Also, the Royal Colleges of Physicians in Scotland, the Royal College of Physicians of Edinburgh, and the Royal College of Physicians and Surgeons of Glasgow. Copies of the advertisement will be sent to the Royal College of Physicians of England.
