A. All correspondence/documents passing betweeen the Medicines Inspectorate Division and BPL and/or the DHSS requesting facilities to inspect Elstree between 1st January 1974 and closure of Elstree and the reaction of BPL and/or DHSS to those requests.

The report of the Medicines Inspectorate Division relating to Elstree published in or about Summer 1979 containing or evidencing their findings with regard to (a) overcrowding (b) drains (e) contamination risks (f) equipment (g) maintenance (h) equipment contaminated by mould (i) unfiltered air (j) production capacity and (k) health and safety risks generally.

Advice given by Professor Ari Zuckerman to the Central Defendants between 1 January 1974 and 31 December 1985 relating to (a) the international commercial market in blood and blood products and associated viral risks (b) the source of blood used in American blood concentrates imported into the United Kingdom and associated viral risks (c) result of tests carried out by Professor Zuckerman on blood products imported into the United Kingdom from America with particular refernce to the risks of hepatitis B and hepatitis NANB (d) the incidence of hepatitis B and NANB in English haemophiliacs treated with imported American blood concentrate (e) the wisdom of causing or permitting English haemophiliacs to be treated with imported American blood concentrate.
