The draft letter to PCTs in para 3 indicates that "for reasons of equity the roll out would be based on age". The letter dated 2 December to UKHCDO (which I take it was sent) in the second para refers to the roll out programme being designed to "benefit as many patients as possible in the first 2 years.." the age limit being calculated based on the money available, the physicians' choice of recombinant and it's tender-price and the cost of the patient's current treatment". It does not seem to me that that is really reflected in the PCT letter. If the intention was to benefit as many people as possible you might consider saying "The Working Group decided that for reasons of equity in order to benefit as many patients as possible the roll out would be based on age....".
