I have made some suggested changes to your letter - see attached.

For clarity the announcement does cover factor VIII & IX and VIIa to the extent that it is clinically indicated for the treatment of inhibitors.

Most suggested changes are self explanatory. I would rather we don't talk about ring fencing the money as it is not generally DH policy to ringfence funds. However, we do need to find a way of making sure that the money is used for the purpose intended.
