Notes in respect of contacts followed up on Nycomed Amersham plc recall, pm Tuesday 18 Nov 1997

In each case, where a voice contact was made, the following line was adopted:

A. Explained the basis of the BPL recall (precautionary recall for nv-CJD donor, under MCA instruction, no evidence of transmission by blood or blood products, but history of classical CJD cannot be assumed to be absolutely predictive for nv-CJD).

B. Since customers were generally concerned to know whether treating physicians/patients should be advised, explained the basis of the ethical committee opinion in respect of transfused plasma products (no test for infection, long incubation period, no treatment). Indicated that these factors should be taken into account when determining local policy.

C. Only one customer sought advice on continued use of product, in the light of non-availability of an alternative product. Again reminded the enquirer of the basis of the recall but made clear that any decision to continue to use affected product should be taken locally, on the basis of a review of risks and benefits to the individual patient.
