#### Re: nvCJD cases with a history of blood donation

Many thanks for your letter and 'phone call of 20th May 1998. We have investigated the four recipients in the Trent Region (did I get the impression you thought there were three?). None of them is registered on the Northern Zone PULSE list of donors.

Your last request however to investigate whether it is possible to ensure that these individuals could not register as donors in the future has caused me some problems. The only way that I can think of doing this, suggested by Cath Chapman, is to register them as new donors and permanently exclude them before they have even turned up. This however would be very obvious should they enrol and they would be very likely to enquire why they were excluded. We would then be obliged to inform them of the reason. This may well be a risk worth taking in view of the potential dangers should they donate. If you think we should go on and do this then please let me know. For the time being I have not acted.

One further thing that I considered was that PULSE is, as you know, Zonal. Two of our donors live in the southern part of the Trent Region and it is conceivable that they might donate in either of the other two Zones. Would you consider excluding them similarly to cover the whole of the country?

The four recipients in Trent (rather than three), their ages are 25, 43, 67 and 68, so two of them at least are potential candidates for donation. These two younger individuals live in the southern part of Trent.

#### nvCJD cases with a history of blood donation

You were recently asked to trace the fate of donations given by an individual registered at your Centre as a blood donor, who subsequently developed nvCJD. You have supplied the details of three recipients in your area, documented to have received blood components from the donor at your Centre.

At this week's meeting of SACTTI, concern was expressed over the possibility that the recipients identified in this exercise could themselves be blood donors, or become donors in the future. Although not all recipients are in the age range for active donors, SACTTI felt that it would be wise to ensure that these individuals were not currently donors, pending any decision which may be made by MSBT for future policy.

Could you please, as a matter of priority, establish whether any of the three recipients identified by you are registered as active donors. If so, measures should be taken to ensure that the donations are discarded and not transfused to patients, although there should be no attempt to notify the donor at this point.

The majority of the recipients are of an age which would probably exclude them from registering as donors in the future. Nevertheless, for those individuals who fall within the age limit for donors, and who are not registered as donors, could you please investigate whether it is possible to ensure that these individuals could not register as donors in future.
